The meeting was called to order at 5:58 PM.

Budget Committee Members Briggs Lockwood, Seth Cohn, Bob Scarponi, Kelly Short, Chris Blair, John Carr and Art Rose attended the meeting.

The Selectmen explained to the Budget Committee that they have plans to submit a warrant article to install an HVAC system at the Municipal Building. Ken notified the Board that he had received a request from the Fire Chief earlier in the day that he would like to submit a warrant article for a new Fire Truck.

A general discussion was held on the proposed Fire Truck Warrant article.

The Selectmen and Committee reviewed the proposed 2015 budget.

The 2015 overall proposed budget is -2.7% from the 2014 budget.

A brief discussion was held on the Capital Reserves. The Conservation Commission has submitted a request to have \$12,000 put into their reserve fund. Ken explained that the Conservation Land Use Change Tax Fund currently has approximated \$122,000 and their reserve fund has approximately \$23,000, with a current total of approximately \$145,000 available to them.

The Selectmen updated the Budget Committee on the Sam Lake House Renovations. A discussion was held on obtaining a secure place for the historical records. Bob Scarponi explained that Historical Society could house them in the Old Elkins Library.

Chris Blair expressed concerns with the existing Town website. A general discussion was held and Kelly offered to contact an alternate company for website services.

The Selectmen thanked the Budget committee for attending and asked them to attend the January 5th meeting for further review/discussion on the proposed 2015 budget.
