II. Administrative

Ken distributed an outline of expenses and a cash flow spreadsheet. Ken reported that the tax collection is within 1 % of where we were at this time last year.

Frank asked if the cardboard baler was operational. Ken responded that it is not and that 3-phase power would need to be brought it. A quote from Unitil was received for approximately \$2,000.

Bob explained that the Selectmen, Fire Chief and Deputy Fire Chief will be having conversations this fall to discuss the purchase of a new fire truck. A brief discussion was held on the aging Jaws of Life equipment.

Bob updated the Committee on the Sam Lake House renovations. They will be interviewing an Architect in the near future.

Bob Scarponi suggested that the \$50,000 in the Rescue Equipment Reserve Account be used to replace the Jaws of Life.

The Selectmen thanked the Budget Committee for attending.

The Board reviewed the Action Item List.
