When the application has been completed, please deliver it to the Town Office along with the appropriate fee. The Planning Board members will address the application at the next scheduled meeting. If the form is completed, the Board members will sign it and the original will be brought to Merrimack County Registry of Deeds. The Registry will record the merger and return the paperwork to the town office.

Copies will be made for the Planning Department files and a copy will be distributed to the Assessing Office.

There is a \$20.00 fee for a voluntary lot merger. This includes the cost of recording at the Merrimack County Registry of Deeds.
