Mike updated the Board of the incidents that occurred from January 19 – February 22, 2021. Mike stated that statewide in 2020, there were 13 fatal fires and 11 of those had no smoke detectors in the home or apartment, which is 85% of the total fatal fires.

The COVID-19 numbers are trending downward, four members of the department have volunteered to assist with the vaccination clinics. There was a small outbreak at Canterbury Hall. The National Guard did the testing, the results have come back all negative.

The Department has one new member, Deputy Chief Nick Baker will be leaving the department on March 1st. Deputy Chief Newbery will be the training supervisor.

Mike will be looking into incident reporting software offered from the NH Fire Marshal's office and is free to municipalities.

Mike will bring back in-person training on March 1st, masks and social distancing will be required. Mike will have all the batteries in the AED's that are housed in town buildings replaced in March.

Mike explained that E-3 is the next truck to be replaced, he will be working on a possible grant for \$600,000.

Mike explained that he has been approached by Al Edelstein about adding an office space to rent above the store. Mike will be working with Al to address some of the safety concerns.

Chance Anderson

ZBA Chair Joe Halla, ZBA Members Calvin Todd, Lisa Carlson and Toni Halla joined the meeting.

Chance had applied to the Zoning Board of Adjustment for a special exception for a short-term rental and a variance for the setback requirement of an Accessory Dwelling Unit (ADU) in August 2020.

Art explained to Chance that the Selectmen had sent him a letter notifying him that he is in violation of zoning by still operating his short-term rental after being denied by the ZBA. Chance was denied a variance for an accessory dwelling unit (ADU). The “tiny earth cabin” didn’t meet the distance requirements set forth in the zoning ordinance. The ordinance states that the ADU must be within 500 feet of the residential structure, his tiny cabin is 900 feet. The zoning board suggested that he move the cabin to meet the setback requirements. Chance explained that the cabin cannot be moved. The ZBA gave Chance 45 days to appeal the decision. Chance did not appeal their decision and is still operating his short-term rental.

Chance stated that his booking is 90% full.

Bob suggested that Chance apply to the ZBA for a special exception for a campground. Joe Halla stated that the proposed campground zoning that is being voted on at the next Town Meeting, states no new structures or lean-to’s. A discussion was held on the wording of the proposed warrant article for campgrounds as it pertains to cabins. The Selectmen will get a determination from the Planning Board on the details and intent of the proposed amendment relative to “camping cabins”.

Chance said that he will get the Fire Department to bring up the UTV to check the access of the cabin. Chance mentioned that he was working on another cabin. Bob stated that Chance must secure any and all permits before building.

The Board explained the process Chance needs to take.

- 1) Apply to ZBA for a Special Exception
- 2) Apply to Planning Board for Site Plan Review

Chance asked if he could get a designee to go before the ZBA. Bob stated that he can have a designee present his case.

Joe Halla stated that Chance is in violation, he was sent a letter which he ignored. Joe feels that the Selectmen are not supporting the ZBA’s decision and they should issue a cease and desist now.

Bob explained that Chance does not have the appropriate permits, he needs to cancel future reservations and stop renting the cabin until he receives the proper approvals. If Chance continues operating without approvals, he will be fined each day he is in violation.

The Board thanked Chance for attending the meeting.

Cheryl stated that the Selectmen will draft a letter to Chance confirming what he needs to do to comply with zoning.

Joe stated that he needs a cease and desist letter. Joe believes that Chance may charge more to cover the fines and continue to rent. He won’t stop until he gets the letter. Joe suggested that a letter be sent remove his listing on Air B & B.

Joe, Calvin, Lisa and Toni left the meeting.

Historic District Commission Chair Kevin Bragg attended the meeting to discuss the demolition of the barn in the center.

Kevin explained that Ken spoke with Ron Turcotte and Judy Nelson, owners of the barn, about the state of the fence around the demolition site. It has fallen down a few times. The fence was repaired but has since fallen down again. Kevin is concerned that when the snow is gone there is nothing to warn or prevent someone, especially children, from entering the area. Kevin asked that the Selectmen write a letter to the property owners saying that the Town has identified this site as a hazard and is requesting adequate fencing and property signage (Construction zone – Do Not Enter) be put up. Ken will have the Code Enforcement Officer, Joel French contact the property owners.

Kevin thanked the Board.

The Selectmen reviewed an email from a property owner asking them to reconsider their abatement request on interest. The property owner did not supply the Selectmen with anything new for them to consider. The Board will not rescind their decision.

The Selectmen reviewed an email from Modern Concepts asking the town to adopt a policy that they will only provide links on the town's website to local businesses only. The Selectmen are not interested in adopting this type of policy.

Ken will have the Code Enforcement Officer, Joel French contact the property owners.

Kevin thanked the Board.

The Selectmen reviewed an email from a property owner asking them to reconsider their abatement request on interest. The property owner did not supply the Selectmen with anything new for them to consider. The Board will not rescind their decision.

The Selectmen reviewed an email from Modern Concepts asking the town to adopt a policy that they will only provide links on the town's website to local businesses only. The Selectmen are not interested in adopting this type of policy.

Ken explained that Treasurer Al Edelstein has contacted TD Bank and would like to set up a joint meeting with the Selectmen to discuss investment opportunities. They will look into coordinating a conference call after town meeting.

Ken reported that he will send out a memo to all departments, boards and commission about sharing any and all decisions made to other departments, boards and commissions.
