16	Review of May 14, 2019 Minutes: Tyson Miller moved the Minutes, seconded by
17	Hillary Nelson. Discussion: None. Vote to approve Minutes: Unanimous – 5/14/19
18	Minutes approved.

20	Board discussion: Zoning Ordinance and Table of Uses:
21	
22	Tyson reported that Ken Folsom, Town Manager, called our town counsel, Bart Mayer,
23	to discuss Air BNB regulations for fire and safety. Since Canterbury doesn't have short
24	term rentals in our Table of Uses, and we have a permissive Zoning Ordinance, short
25	term rentals are not allowed. Jim Snyder disagreed with the interpretation and doesn't
26	think it gives the Selectmen the ability to prohibit short term rentals. There was
27	discussion about short term rentals as an accessory use of a single family dwelling, and
28	about litigation in Portsmouth that is currently at the Supreme Court relating to this
29	subject. The Board discussed fire safety checks and the type of approach it would take
30	for enforcement of short term rental complaints. We will look at this issue again after
31	current legislation is decided on and the Supreme Court issues a decision.
32	
33	Hillary Nelson discussed the research she's found over the past couple weeks relating
34	to obnoxious uses and what the Planning Board's possible involvement could be
35	through Site Plan. She passed out a model noise ordinance from a city, but felt there
36	were some things we could use from it and thought it was a great starting point. The
37	model she provided relies on the reasonable person standard rather than using
38	decibels.
39	
40	Tyson passed out the proposed notice for the Canterbury newsletter for everyone's
40 41	review. After further discussion, Hillary agreed to review it for possible further edits and
41 42	eventual posting in the Newsletter.
