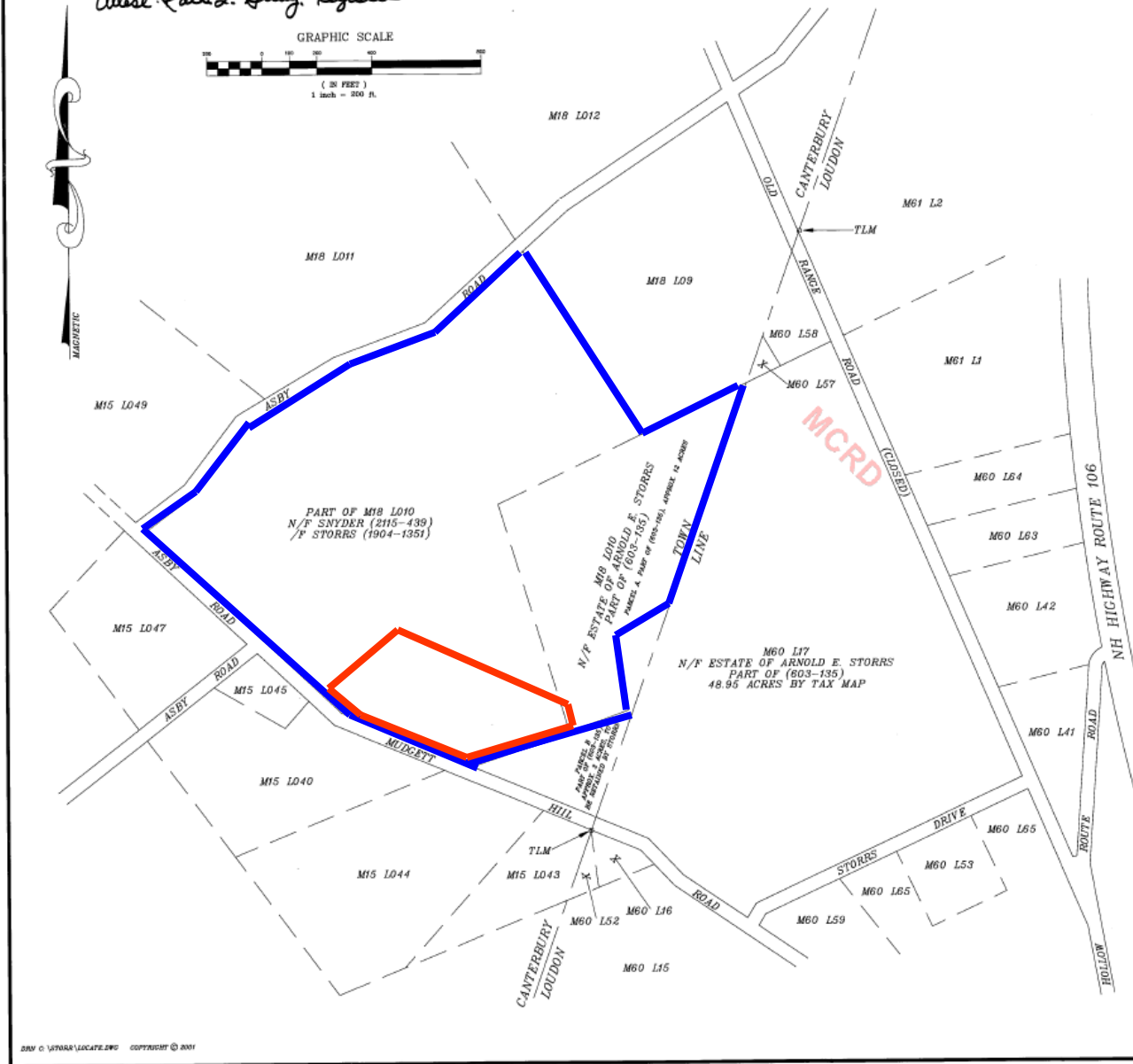
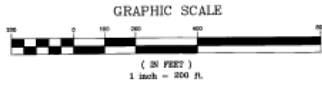

1. THE PURPOSE OF THIS DRAWING IS TO SHOW THE VICINITY OF A PROPOSED BOUNDARY LINE ADJUSTMENT NEEDED TO SATISFY PARAGRAPHS 4, 5 & 6 OF "SETTLEMENT AGREEMENT" FOR MERRIMACK COUNTY SUPERIOR COURT DOCKET NO. 99-8-0792, SNYDER V. STORRS & STORRS.
2. THE BASIS FOR THIS MAP IS AS FOLLOWS: A. CANTERBURY TAX RECORDS, B. LOUDON TAX RECORDS, C. 1954 TOWNLINE PERAMBULATION NOTES FOR CANTERBURY & LOUDON, ON FILE AT THE TOWN OFFICES AND D. "BLISTER BUST MAPS", ON FILE AT THE STATE ARCHIVES.
3. THIS DRAWING IS NOT A SURVEY PLAT, IT IS RATHER ONLY A LOCATION MAP.
4. THE SURVEY DEFINITION OF THE NEW BOUNDARY LINE IS SHOWN ON SHEET 1 AND IS BASED ON AN ACTUAL FIELD SURVEY OF 1/8/2001.
5. THE "ARNOLD E. STORRS ESTATE LAND" IS NOW TAXED AS "CURRENT USE LAND" UPON THE CONVEYANCE OF "PARCEL A" TO SNYDER IT SHALL BE MERGED WITH OTHER LAND OF SNYDER M15 L010, AND "PARCEL B" SHALL BE RETAINED BY STORRS AND UNDIVIDED FROM THEIR TOTAL REMAINDER TRACT, PARTLY IN CANTERBURY AND PARTLY IN LOUDON, AND NOW IN "CURRENT USE".
